Gisborne born couple Rod Glengarry and Sue Leslie have recently finalised their Wills, leaving a portion of their estate to The Sunrise Foundation, where a scholarship fund will be established to assist young people wanting to attend tertiary education outside of Gisborne.

"We hope this fund will make a big difference in students' lives, helping them realise their dreams and aspirations," says Sue.

Sue has a background in education and currently works with several local schools, mainly at secondary level.

"We don't have kids of our own and I'm in education which is what initiated the idea of a scholarship fund with Sunrise. We love the idea that it will go on helping kids year after year," says Sue.

"It might break a cycle in a family, perhaps sending the first person from a family to University who wouldn't have been able to attend otherwise," says Rod.

After years living in Auckland, and then London, the couple returned to Gisborne in 2020 to the family home that Rod's architect father Monty had designed and built in 1959. The home has remained in the family since.

As an architect himself, Rod says, "The renovation is certainly a labour of love. At our time of life, we're restoring it thinking that someone else is going to be living here. We'd like to think the house will be passed on to someone who will appreciate the style and its original features."

New pontoon saves the season

Poverty Bay Kayak Club (PBKC) used their Sunrise grant to purchase a new pontoon for club paddlers, replacing the original jetty that was lost during Cyclone Gabrielle.

PBKC received a grant from the General fund in our annual funding round. Applications are invited once a year and reviewed by our grants committee to ensure funds are directed to where they will have the greatest impact, benefiting groups or organisations across the arts, education, environment, community, health, and sport.

The new pontoon the club purchased was split in half, with one part used to access the river outside their club at Anzac Park allowing training sessions for experienced paddlers to continue, and the other half was set up at a private lake in Manutuke.

Having a pontoon on the lake meant paddlers were able to continue training during times when access to Anzac Park was restricted in the aftermath of the cyclone. Without the pontoon the lake would have been completely inaccessible to some of the younger or inexperienced paddlers.

"Having the pontoons has meant we were able to continue paddling and even grow our membership despite the effects of Cyclone Gabrielle. This would not have been possible without the grant provided by Sunrise," says Liz Thompson, coach.

PBKC held a mini regatta at the lake which Liz says was thoroughly enjoyed by paddlers of all ages and levels and would not have been possible without the pontoon.

At-risk rangatahi at the heart of Matapuna

Matapuna Trust Board recently established an endowment fund with Sunrise as part of their governance work to secure the Trust's long-term future.

Knowing Sunrise will invest donations in perpetuity (forever) and distribute the investment income back to Matapuna every year forever appealed, as it gave the Trust confidence the fund will support their ongoing viability.

"Our Sunrise fund will provide a level of independent funding, where our Matapuna Trust Board will have discretion over where the funds will be most beneficial," says Jodie Cook, Matapuna Training Centre, CEO.

"Having a Sunrise grant every year will enable us to provide support for at risk youth and adults in a need based, flexible way," says Jodie.

Reliant on charitable funds every year to operate, the Trust felt restricted at times by government contracts and funding rules. This led to discussions about establishing a fund with Sunrise, knowing they would have control of how to use their annual grant in a way it will have the most impact for their students.

The Matapuna team is committed to growing the fund through a range of activities over the near future, so they can continue helping rangatahi through the holistic wrap-around support system they offer. By removing or minimising barriers to learning, Matapuna hopes for all their students to achieve their goals and realise their potential.

Generous parishioners seed new Stella Maris fund

An anonymous group of local parishioners have gifted \$50,000 to The Sunrise Foundation to seed an endowment fund for Stella Maris Catholic Early Childhood Centre. The gift is intended to help those children in greatest need.

The new fund will support children from families who are struggling financially to participate fully in the life of Stella Maris. Specifically, it will assist children in the spiritual, academic, cultural, and general activities of Stella Maris.

Bridget Armstrong, Stella Maris centre leader, said she felt incredibly blessed and honoured to be at the receiving end of such a selfless act of generosity.

"In future years, an annual grant from our fund will help us support parents who need extra financial assistance. Perhaps, subsidise fees to help those who would like to increase their child's hours of care but can't afford to," says Bridget.

When Stella Maris opened its doors on Campion Road approximately one year ago, Bridget says if felt as if they'd completed the Catholic community.

"We have St Mary's Star of the Sea church and Campion across the road, St Mary's right next door, and now us. It's a full circle and means as the children grow, progressing from one education area to the next, it's pretty stress free for them," says Bridget.

All donations made to the Stella Maris endowment fund are invested and protected for the future. Every year the investment income is distributed back to Stella Maris as a grant, meaning your donation will continue supporting the centre forever.

Teach a man to fish, you feed him for a lifetime

Sunrise awarded ETu Elgin a grant of \$5000 on behalf of The Tindall Foundation which will contribute towards operating costs of their planned sustainable skills courses for whanau living in Elgin.

E Tu Elgin are a community-based support group whose committee currently live or were raised in Elgin. By teaching sustainable skills that their ancestors would have used daily E Tu Elgin hope to provide whanau with the opportunity to connect to their culture.

Rewana bread making, bulk food cooking, weaving, baking and household financial literacy are just some of the skills they have planned for Elgin community whanau soon.

Hineiti Monika, E Tu Elgin committee secretary says, "With the help of experts we want to provide whanau with opportunities they wouldn't usually get.

"We want to teach skills to last a lifetime, which can be retaught to younger whanau, strengthening our community."

Hineiti says, "The old saying 'If you give a man a fish you feed him for a day. If you teach a man to fish, you feed him for a lifetime' is what we're all about - learning skills for a lifetime which can be shared with others."

E Tu Elgin is community driven, where feedback is valued by the committee to ensure courses and events they offer align with what the Elgin community wants and needs.


The Sunrise Foundation is a simple and lasting way to support local charities, organisations and causes that are important to you.

All donations and bequests to Sunrise are invested in endowment funds in perpetuity (forever). Every year some of the investment income is retained to ensure your gift grows in line with inflation. The balance of the income from investments is distributed to worthy causes throughout the Tairāwhiti-Gisborne District each and every year forever.



Over 20 years your donation will double in size and grants to the value of your original donation will have been granted to worthy causes. Over 50 years your donation and the total grants to our community will be 5 times more than your original donation.

99% of your donation works for our community

As a community foundation Sunrise can only retain a maximum of 1% of endowment value each year to cover operating costs.
